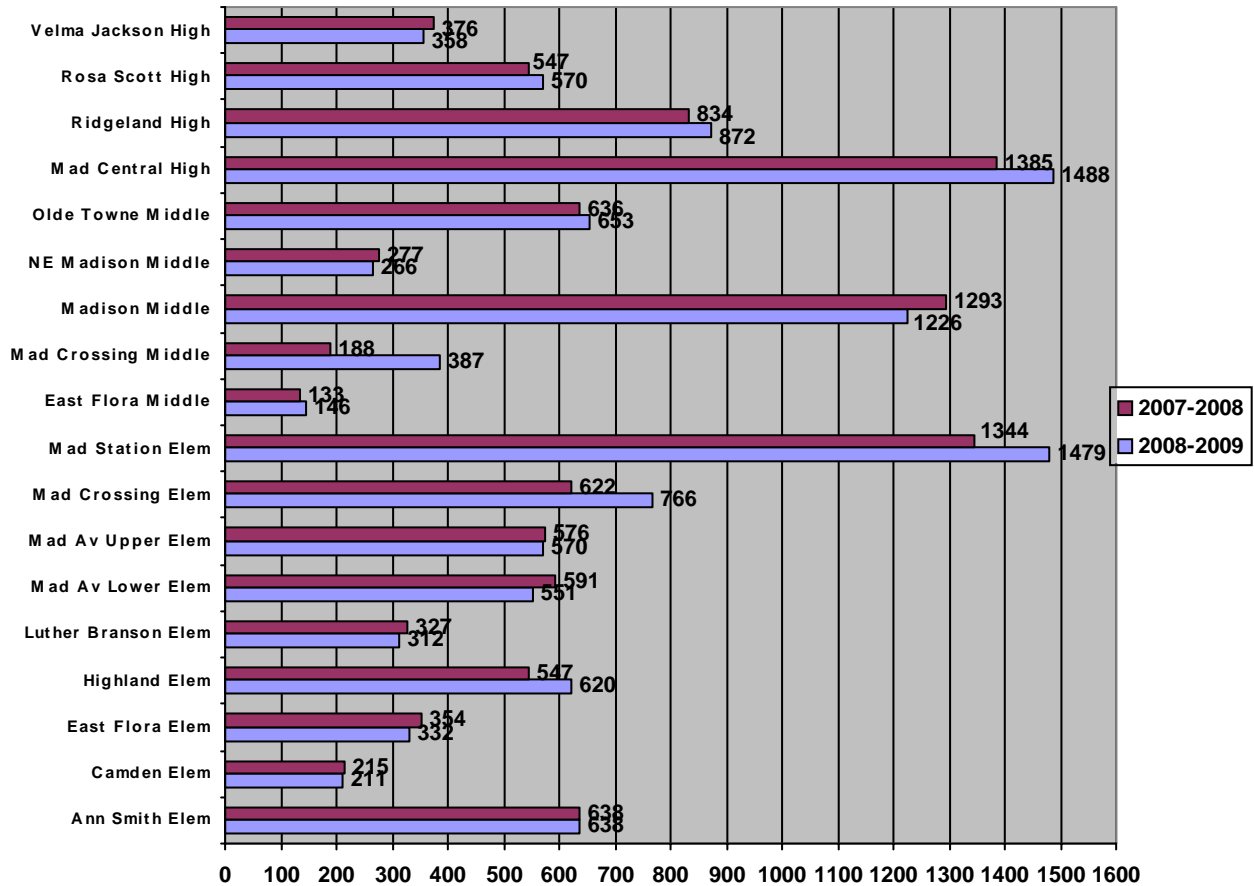

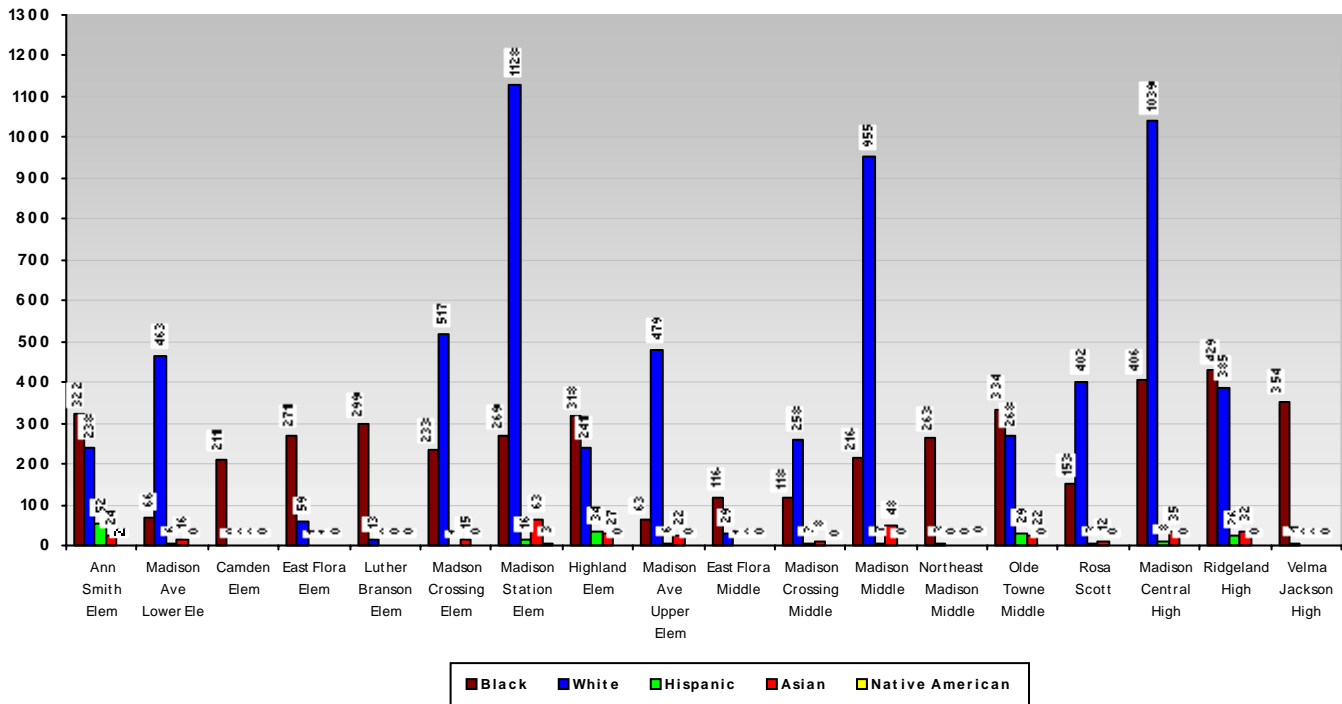

# No Child Left Behind

The No Child Left Behind Act of 2001 (NCLB) requires school, district, and state report cards containing certain information. The required information falls into three general areas: school improvement, teacher qualifications and test data. A school that fails to make adequate yearly progress for two consecutive years must be identified for school improvement. The report must contain information about the professional qualifications of teachers in core academic subject

areas (English II, reading, language arts, biology, science, mathematics, Algebra I, and U.S. History). Highly qualified teachers are those who are fully certified and are teaching in their area of endorsement. The report must also contain achievement data for specific subgroups, two-year achievement trends, and student participation rates.

In the Spring of 2008, Mississippi students took the *new* Mississippi Curriculum Test, Second Edition (MCT2). The (MCT2) is a measure of student achievement in Language Arts and Mathematics in grades 3-8 based on the *2006 Mississippi Language Arts Framework - Revised* and *2007 Mississippi Mathematics Framework - Revised*. In addition to being the basis for state accountability in these grades, the MCT2 is designed to meet the federal testing requirements of the *No Child Left Behind Act (NCLB), 2001*.

The MCT2 was administered May 13-14, 2008. Language Arts was administered on day one and Mathematics on day two. The results of the first administration was reported for federal and state accountability purposes in August 2008.
